TERMS & CONDITIONS

Pre-Payment:

Each event requires a 25% non-refundable deposit due at the signing of the contract. All events are required to be paid in full three business days prior to the event date by way of a pre-payment schedule outlined in the contract. Payments may be made by credit card, certified check, cash or wire transfer.

Guarantees:

A guaranteed number of guests attending your event is required by noon, three business days prior to the event day. You will be charged for the guarantee or the number served, whichever is greater. The Hotel cannot be responsible for any greater than a 3% increase above the guarantee the evening of the event. In the event that no guarantee is given, the original number of guests contracted will be used for billing.

Service charge:

All food, beverage and room rental is subject to a 24% taxable service charge. Additional staff members required for chef-attended stations, security supervision or coat checks will incur an added cost.

*Multiple entrée selections are limited to three total selections and will incur an additional cost. All pricing is subject to a 24% service charge and a 10% tax.
